Department for Children, Youth and Families Backup Material for Transportation Renewal Contract Authorization with Rejha Group L.L.C. for Children with Special Needs Who Travel to Special Education and Therapy Programs

The Department for Children, Youth and Families is requesting that the Albany County Legislature authorize the County to enter into an agreement with Rejha Group L.L.C., for transportation services for children with special needs. Contracts for transportation services are divided into zones based on program locations. There are six unique zones. The Department is seeking authorization to exercise the first of two options to renew for all 6 zones. The total funding for all zones is not to exceed \$4,631,313.00. The contract term of all six contracts will run from September 1, 2021 to August 1, 2022.

The Department issued a Request for Proposals for Transportation Services for pre-School Aged Handicapped Children in Need of special Education—*RFP-2020-030--* on February 17, 2021 with responses due March 26, 2021. It should be noted that Rejha Group L.L.C was the only company that submitted a proposal.

Transportation of children with special needs to special education and therapy services, as recommended by the individual education/family service plan approved by the child's school district or by the Early Intervention Official, is mandated by New York State law.

Given the varying fluctuations in the fuel market, proposing vendors need to anticipate any potential increases in fuel costs so that they are not inadvertently penalized for swings in the fuel market. This puts the County in a vulnerable situation; requiring it to pay for costs that may not actually be incurred assuming a stabilized fuel market. In order to better safeguard the County financially, the Department, with assistance from the County's Purchasing Department, have structured the bids with a fuel escalation/de-escalation clause. This language provides a safety valve for both the County and the transportation provider so that the effect on either entity's bottom line is minimized in the event(s) of changes in the fuel commodity market.

The costs associated with transportation are reimbursed by the State at a rate of 59.5% after subtracting out any reimbursement received from Medicaid. All contracts will be reviewed and approved by the County Attorney's Office as to form and content prior to execution.

Albany County seeks to participate in the Emergency Rental Assistance Program (ERAP) managed by the NYS Office of Temporary and Disability Assistance (OTDA). ERAP is a federal assistance program to prevent utility cut off and eviction of households with financial hardship due to the Covid pandemic. DSS and partners will provide community outreach to hardest hit households to help them enroll in the OTDA created application portal. OTDA will oversee the application portal and process applications for assistance, verify eligibility criteria, determine eligibility and provide financial assistance directly to landlords and utility companies for this Program. The total allocation has been set aside exclusively for Albany County to conduct outreach and engagement.

An ERAP eligible household is defined as a renter household in which at least one or more individuals meets the following criteria:

- 1. Qualifies for unemployment or has experienced a reduction in household income, incurred significant costs, or experienced a financial hardship due to COVID-19;
- 2. Demonstrates a risk of experiencing homelessness or housing instability; and
- 3. Has a household income at or below 80 percent of Area Median Income.

Eligible households that include an individual who has been unemployed for the 90 days prior to application for assistance; households with income at or below 50 percent of Area Median Income will be prioritized for assistance. DSS will be targeting households with under 50% AMI to engage those most at risk for eviction

The poorest in our community and most vulnerable come to DSS for assistance. DSS has an Emergency Team who will be well informed about ERAP and assist in enrolling the most at-risk tenants. DSS is also working with community providers with extensive experience assisting very low income households with housing issues. We have contracted with two specific partners to assist in our outreach and assistance efforts: United Tenants of Albany and Legal Aid Society of Northeastern New York. United Tenants has a hotline familiar to and

utilized by low income households. Legal Aid works with low income individuals and the courts to prevent evictions.

Information, materials and links are found on the OTDA website and will be highlighted on the County Website. Assistance will be provided to tenants in gathering documentation required under ERAP and helping to bridge technology issues that may occur among vulnerable populations not accustomed to navigating an on-line portal. If landlords or tenants are experiencing difficulty accessing the portal or completing the application, assistance will be provided by DSS and our partner agencies.

An application for rental assistance may be submitted by either an eligible household or by a landlord on behalf of that eligible household. In general, funds will be paid to the landlord or utility service provider.

Consistent with the recently executed Intergovernmental Agreement between Albany County and the State Office of Temporary and Disability Assistance (OTDA) regarding the Emergency Rental Assistance Program (ERAP), a sum of \$906,175.32, representing 10% of the amount that was directly allocated to Albany County from the U.S. Treasury under Section 501 of the Consolidated Appropriations Act, 2021, has been reserved by OTDA to reimburse Albany County for costs it incurs in implementing ERAP, providing outreach to eligible households, and in assisting them in applying for rental and utility arrears payments. This allocation will be provided through a direct contract with OTDA. It is anticipated that this contract will be amended in the future to add a second allocation in the amount of 10% of the municipality's direct allocation from the U.S Treasury for ERAP as outlined in Section 3201 of the American Rescue Plan. Please be advised that the contract term will be January 1, 2021 to September 30, 2022.

Our office is committed to making this a straightforward and efficient process. All contracts will be developed using the NYS Grants Gateway portal. For your reference, the Grants Gateway Vendor User Guide can be found at https://grantsmanagement.ny.gov/system/files/documents/2020/05/vendor-user-manual-3.2-5.7.20.pdf. Please see instructions on pages 79-88 on finding and developing your contract.

Budget screens will need to be completed line-by-line in Grants Gateway and an associated workplan will need to be developed. The workplan should include a description of how outreach efforts to communities will occur and by whom. Also include information about where application assistance will be offered and by whom.

Proof of current Workers' Compensation and Disability Insurances must also be uploaded to the Grantee Document Folder with OTDA listed as the Certificate Holder. This proof must also be supplied for any and all subcontractors.

Your municipality will play a critical role in serving those most in need in New York State. We will be contacting you shortly to assist you in the contracting process. HATAS provides non-business hour coverage (i.e. evenings, nights, weekends and holidays) to serve individuals and families who present as homeless or at imminent risk of homelessness by assisting them to access needed emergency shelter or diverted from homelessness by retaining or securing adequate housing. HATAS was selected via RFP # 2021-055 (they were the sole bidder) and are the previous provider of these services. As a local social services district, the Albany County Department of Social Services is responsible for securing temporary/emergency shelter placement for homeless persons who are eligible or potentially eligible for Temporary Assistance. DSS is also required to shelter all persons who present as homeless during Code Blue (weather under 32 degrees Fahrenheit). Homeless and Traveler's Aid Society will work with the Department of Social Services in communicating to the public and to shelters those nights which are defined as "Code Blue" as outlined by NYS Executive Order 151 and NYS Office of Temporary Disability and Assistance directives. During Code Blue nights, shelter must be provided to homeless individuals and families regardless of eligibility for Temporary Assistance; or for those individuals or families, who are eligible for Temporary Assistance, but have been determined by a shelter as someone whom they are unwilling to shelter due to behavioral/non-compliance issues.

Justification: (State briefly why legislative action is requested) Albany County Department of Social Services (DSS) is requesting permission to apply for a USDA 2021 SNAP Process and Technology Improvement Grant for funding for a SNAP Centralized Call Center and Ventek, Inc. workflow management and status tracking software. Albany County receives approximately 25,000 SNAP calls annually. Our staffing levels are such that we are not able to address the high volume of calls we receive each day. This delay in returning calls or inability to return a call at all further increases the number of duplicate calls and creates unnecessary traffic in our Reception Area. The volume of calls and in-person visits to have questions answered and conduct interviews, takes staff away from processing applications in a timely and efficient manner. In addition to the challenges with call volume, Albany County Department of Social Service's SNAP Division operates a manual "task-based" workflow process for 18,208 cases, whereby work is distributed in batches by task to various staff and completion/status is tracked through individual work logs. This manual "task-based" process is arduous when tracking down a case to answer the questions of SNAP clients via telephone. Albany County requires a more efficient workflow process to better distribute, monitor and manage SNAP cases. In order to improve our overall workflow, increase our ability to respond to calls, and better meet the needs of the individuals we serve, we have determined that establishing a SNAP Centralized Call Center with the addition of six dedicated staff and the implementation of technology, software and training would help us achieve this important goal. This SNAP Centralized Call Center will also promote efficiencies in making case changes immediately when a call is received and meeting case processing requirements in a timely manner. DSS is requesting \$692,357 from the USDA SNAP Process and Technology Improvement Grant, which will cover staff salaries and fringe for six staff for the first year of the grant, the purchase of a call center phone system, call center data collection software, ,workflow management and status tracking software, and essential training and furniture, needed to establish the call center. The development of a call center and implementation of a workflow management system will significantly improve our SNAP work processes and provides an enhanced level of customer service to the individuals we serve. We expect less "churn" of clients calling multiple times or visiting the DSS Reception area unnecessarily when most issues can be handled over the phone for SNAP.

The purpose of this GIS is to inform social services districts (districts) that the United States Department of Agriculture (USDA) has issued a grant competition for Process and Technology Improvement grants to support efforts by state agencies (which includes local districts in locally-administered states like New York) and their community-based and faith-based partners to develop and implement plans to:

- Improve customer service, or
- Improve the application and interview process.

As indicated in the attached Request for Applications (RFA) and at FY 2021 Process and Technology Improvement Grants (PTIGs), USDA is seeking diverse proposals that would make the entire process easier and more efficient for applicants and participants.

This year, the USDA is particularly interested in funding projects that advance racial equity and inclusion and/or serve underserved populations such as Black, Latino, and Indigenous and Native American persons, Asian Americans and Pacific Islanders and other persons of color; members of religious minorities; lesbian, gay, bisexual, transgender, and queer (LGBTQ+) persons; persons with disabilities; persons who live in rural areas; elderly persons; Limited English Proficiency (LEP) persons; and persons otherwise adversely affected by persistent poverty or inequality.

Districts are strongly encouraged to apply. Grant proposals should focus on improving the client's experience. Specifically, the USDA FNS, is interested in initiatives that:

- Improve SNAP customer service responsiveness and effectiveness.
 - e.g., projects that modernize call centers, increase effective community partnerships, or support collaborative stakeholder efforts for business process improvement.
- Improve preparedness for public health emergency and pandemic response by strengthening virtual and disaster response operations.
 - e.g., projects that improve telephone interview capabilities, modernize verification processing (document imaging, scanning, and indexing software and equipment) or public health emergency, disaster and pandemic response training for staff.
- Increase effective partnerships with community partners to improve customer service responsiveness and effectiveness and collaborate with stakeholders in user testing, focus groups, business process improvement efforts, or other methods to determine ways to improve SNAP customer service.

Please note on page 18 of the RFA that all applications will require a "letter of endorsement," from the New York State Office of Temporary and Disability Assistance (OTDA). Requests for letters of endorsement should be submitted to OTDA, along with a synopsis of your district's grant proposal, no later than close of business on Friday, June 4, 2021.

If your district is considering development of a proposal for a Process and Technology Improvement Grant, we recommend that you discuss your proposal first with the OTDA before requesting a letter of support and before committing resources to the development of a proposal so that we can discuss the scope of the State's Integrated Eligibility System (IES) program which is now underway as it pertains to any such proposal. Knowing what technology, equipment and business process re-engineering are within the scope of the IES program before developing a grant will help to ensure that whatever technology, equipment or business process re-engineering investment a district pursues will not be duplicative of efforts within the scope of IES and will be able to be integrated into IES.
