### LOCAL LAW "I" FOR 2021

# A LOCAL LAW OF THE COUNTY OF ALBANY AMENDING LOCAL LAW NO. 1 FOR 2013, ENTITLED "AN OMNIBUS HUMAN RIGHTS LAW FOR ALBANY COUNTY"

Introduced: 9/13/21

By Ms. Chapman, Messrs. Feeney and A. Joyce:

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF ALBANY AS FOLLOWS:

### **SECTION 1. Title**

This Local Law shall be known as the "CROWN (Creating a Respectful and Open Workplace for Natural Hair) Amendment" for Albany County.

### **SECTION 2. Legislative Intent**

The purpose of this Local Law is to prevent employment discrimination based on natural hair texture and/or the use of protective hairstyles in Albany County.

Albany County is dedicated to protecting the rights of its residents and eliminating discrimination and bias in the workplace.

This Legislature hereby finds and determines that the history of our nation is riddled with laws and societal norms that subject those with certain visible characteristics, including natural hair texture and/or the use of protective hairstyles, to separate and unequal treatment in professional settings.

This Legislature further finds that, despite the efforts to reverse racist ideologies, natural hairstyles including braids, locs, cornrows, twists, Bantu knots, poufs, and Afros continue to be a source of prejudice that have serious professional and economic consequences for individuals in Albany County.

Therefore, the purpose of this law is to amend the Albany County Omnibus Human Rights Law (Local Law No. 1 for 2013, as amended) to ban discrimination against the use of protective hairstyles and the wearing of natural hair textures.

### **SECTION 3. Prohibitions**

Section 7, subsection 1. of Local Law No. 1 for 2013, "An Omnibus Human Rights Law for Albany County," as amended, is further amended by the addition of a new subdivision (j) as follows:

(j) It shall be an unlawful discriminatory practice for an employer, employment agency, or licensing agency to deny any license, employment, or promotion to any individual by reason of the person's natural hair texture or use of protective hairstyles. The term "protective hairstyles" shall include styles such as braids, locs, cornrows, twists, Bantu knots, poufs, and similar styles meant to protect natural hair.

### **SECTION 4. Severability**

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm, or corporation, or circumstance, shall be adjusted by any court of competent, jurisdiction to be invalid or unconstitutional, such order or judgement shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm, or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

### **SECTION 5. Effective Date**

This law shall take effect immediately upon its filing with the Secretary of State.

### Memorandum of Understanding

Made by and between Albany County (Employer) and Teamsters Local 294 District Attorney Investigators Unit (Employee Collective Bargaining Unit) (collectively, the "parties") this 6th day of August, 2021, subject to approval of the County Legislature and ratification by the Employee Collective Bargaining Unit.

WHEREAS, the parties entered into a collective bargaining agreement that expired on December 31, 2016 and;

WHEREAS the parties were subject to a binding arbitration decision regarding the fiscal years of 2017 and 2018 and;

WHEREAS, the Parties negotiated in good faith and continue to negotiate in good faith; and

WHEREAS, the parties have reached an agreement relating to the terms of a collective bargaining agreement between the parties and;

NOW THEREFORE, in consideration for the mutual undertakings and covenants herein contained, the parties stipulate and agree as follows:

- 1. The term of the collective bargaining agreement shall be from January 1, 2019 through December 31, 2021.
- 2. All other Articles, terms and conditions and provisions of the Collective Bargaining Agreement not mentioned herein shall remain and be the same as set forth in the January 1, 2010 Collective Bargaining Agreement and shall have full force and effect for the term of the agreement between the parties from January 1, 2019 through December 31, 2021.
- 3. Appendix A Section 1 Amend the existing language in Section 1 to include the following:

Increase all District Attorney Criminal and Senior Criminal Investigators base pay by the following rates:

Effective January 1, 2019, a 2% increase to all salaries – retroactive to 1/1/2019;

Effective January 1, 2020, a 2% increase to all salaries - retroactive to 1/1/2020;

Effective January 1, 2021, a 2% increase to all salaries – retroactive to 1/1/2021;

4. All retroactive pay shall be calculated and paid out as soon as practicable after the date of signature of this MOU.
