RESOLVED, By the County Legislature of the County of Albany that a public hearing on proposed Local Law No. "M" for 2021, "A LOCAL LAW CONCERNING THE CUTTING, REPLACING AND PRESERVATION OF FOREST LANDS BY COUNTY AUTHORITIES" to be held remotely by the Albany County Legislature at 7:15 p.m. on Tuesday, January 25, 2022, with participation information to be made available on the Albany County website, and the Clerk of the County Legislature is directed to cause notice of such hearing to be published containing the necessary information in accordance with the applicable provisions of law.

A LOCAL LAW CONCERNING THE CUTTING, REPLACING AND PRESERVATION OF FOREST LANDS BY COUNTY AUTHORITIES

Introduced: 11/8/21 By: Mr. Perlee

SECTION 1.

Legislative Intent.

Trees play an essential role in the survival of our planet. Trees mitigate temperature fluctuation and lower air temperatures. Trees prevent soil erosion, regulate the hydrology of soil and groundwater levels and absorb surface water, preventing it from flowing into built up and paved areas that contain pollutants that contaminate our waterways. Trees provide aesthetic comfort to urban landscapes and help delineate and buffer areas of current and future development. Through photosynthesis trees sequester harmful carbon dioxide and release life giving oxygen. Certain species which were once abundant in our County, such as the White Pine and Black Locust, are particularly effective at carbon sequestration. By regulating the exchange of energy and water between earth's surface and atmosphere, trees are our planet's primary defense in the battle against global warming. If the present rate of tree removal and death is not addressed, we will lose our last tree, and with it the planet, in less than 200 years' time. It is the intent of this law to create a replacement protocol related to the cutting of forested lands of one-half acres or more owned by Albany County and to create an Albany County Forest Preserve which shall serve to help ensure the preservation and enhancement of the total amount of forest land within Albany County.

SECTION 2.

Protocol related to the cutting of forest lands owned by Albany County.

No area of forested land of one-half acre or greater owned by the County shall be disturbed and developed unless:

- (a) an inventory of trees to be disturbed and /or removed is made and filed with the Albany County Soil and Water Conservation District ("ACSWCD"). The survey will conform with generally accepted standards of professional tree surveying and will comprehensively and accurately indicate the species and size of all trees 4" and greater diameter at breast height; and
- (b) the ASCWCD will determine the value of the trees to be removed ("tree replacement value") using the Basic Formula Method from the *Guide for Plant Appraisal 10th Edition* by the International Society of Arboriculture;

- (c) the County Executive shall place, or cause to be placed an amount equal to two times the tree replacement value ("replacement payment") into a special Forest Replacement Reserve Fund ("Reserve Fund") established for the purpose of purchasing replacement forest property;
- (d) upon confirmation of deposit of the replacement payment, the ASCWCD shall certify compliance with this section and issue an authorization to proceed with disturbance and/or removal.

SECTION 3.

Purposes of the Reserve Fund.

Funds deposited within The Reserve Fund shall be utilized exclusively for the following purposes:

(a) to purchase lands suitable for reforestation to be held in fee simple by the County (b) costs directly associated with planting said purchased lands with tree species known to possess high carbon dioxide sequestration capabilities;

SECTION 4.

Acquisition and Maintenance of Replacement Forest Property.

No more than one year following an authorization to disturb county forest lands, the County Executive shall identify and caused to be purchased real property suitable for replacement forest. Said property shall:

- (a) be designated as Albany County Forest Preserve and shall be operated and maintained as natural open space in accordance with New York State General Municipal Law, Section 247;
- (b) be no smaller in area than two times the area of the parcel containing the disturbed forest land it replaced;
- (b) be suitable for reforestation;
- (d) be located in an area of the County otherwise underserved by County facilities;
- (e) be located where it can serve as a permanent green buffer to existing or proposed development;
- (f) be contagious or in proximate vicinity to lands designated as County Forest Preserve, if applicable;
- (g) be forever kept as forest lands;
- (h) be capable of use for nature education programs, nature trails and other County recreation purposes.

SECTION 5.

State Environmental Quality Review Act Compliance.

This County Legislature determines that the adoption of this Local Law constitutes a "Type II action" as said term is defined in the State Environmental Quality Review Act ("SEQRA"), and that no further action with respect to same is required under SEQRA.

SECTION 6.

Severability.

If any section, subsection, sentence, clause, phrase or other portion of this law is, for any reason, declared unconstitutional or invalid, in whole or in part, by any court of competent jurisdiction, such portion shall be deemed severable, and such unconstitutionality or invalidity shall not affect the validity of the remaining portions of this law, which remaining portions shall continue in full force and effect.

SECTION 7.

Effective Date.

This local law shall take effect upon filing with the New York Secretary of State.

The Department of Economic Development, Conservation and Planning is seeking authorization to submit a project proposal for funding to Capital Region Partnership for Invasive Species Management (PRISM). The project, not expected to exceed \$7,200, will address eradication of the invasive plant lesser celandine at Ann Lee Pond Nature and Historic Preserve. The invasive plant is spreading quickly and threatening the native plant diversity and habitat at the preserve. Due to the size of the infestation, the area must be treated with an herbicide. This will be the second year of treatment, after which, it is expected that any remaining or new growth can be controlled by hand-pulling. This will be performed by a certified applicator and under a NYS DEC permit and a variance from the County Pest Management Committee. Funding for the Capital Region PRISM is provided by the Environmental Protection Fund, administered through a sub-contract with the New York State Department of Environmental Conservation.

WHEREAS, The Department of Economic Development, Conservation and Planning has requested authorization to enter into an agreement with Cornell Cooperative Extension of Saratoga County in collaboration with the Capital-Mohawk Partnership for Regional Invasive Species Management (PRISM) regarding the removal of Lesser Celandine at the Ann Lee Pond in an amount not to exceed \$7,200 for a term commencing March 1, 2021 and ending December 20, 2021, and

WHEREAS, Lesser Celandine is an invasive perennial flowering plant species that has been detected near the northern parking lot in a drainage area of the Ann Lee Pond and needs to be removed, and

WHEREAS, The Department has indicated that the agreement would allow PRISM to manually eradicate Lesser Celandine from the Ann Lee Pond Nature and Historic Preserve as a project to be performed by a certified applicator under a New York State Department of Environmental Conservation (NYSDEC) permit and pursuant to a variance from the County Pest Management Committee, and

WHEREAS, The Department has also indicated that a budget amendment is necessary to incorporate said funds into the 2021 Department of Economic Development, Conservation, and Planning Budget, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to execute an agreement with Cornell Cooperative Extension of Saratoga County in collaboration with PRISM regarding the removal of Lesser Celandine at the Ann Lee Pond in an amount not to exceed \$7,200 for a term commencing March 1, 2021 and ending December 20, 2021, and, be it further

RESOLVED, By the Albany County Legislature, that the 2021 Department of Economic Development, Conservation, and Planning Budget is amended as follows:

Increase Revenue Account A3075 PRISM Partnership by \$7,200



Dear Mr. McCoy:

On behalf of the New York State Office of Parks, Recreation and Historic Preservation, in accordance with Snowmobile Program guidelines, I am pleased to announce the 2021-2022 application for snowmobile trail development and maintenance assistance has been approved for \$12,756.00. These funds will provide financial assistance for maintaining approved snowmobile trail miles within your county, as listed in the enclosed mileage table. All funded trails must provide public access to any snowmobile, currently registered in the state.

Funding is determined through a formula based on approved trail miles in your county, with Corridor and Secondary Class A trails funded at \$336/mile, Corridor and Secondary Class B trails funded at \$276/mile, and a High Snow allotment, if any, funded at \$300/mile. A breakdown of trail miles and award calculations is enclosed for your reference.

The local assistance will be provided in two payments. The first, payment of \$8,929.20, represents 70% of the total award value and will be advanced upon return of the enclosed State Aid Voucher. The voucher must be signed by the Chief Fiscal Officer of your county or municipality. A second payment of \$3,826.80 represents the remaining 30% and will be sent after audit of the Phase III documentation submitted to this office has been completed at the close of this year's snowmobiling season. If any club fails to meet their maximum award amount, it may result in a reduced 30% payment or require reimbursement to the state for the overpaid amount, issued in the 70% voucher.

This year over \$4,200,000.00 is being made available to municipalities for the maintenance, development, and support of over 10,500 miles of snowmobile trails throughout the state. The funding level is based upon the anticipated fees collected from snowmobile registrations.
