 - i. Discussion: Marie presented a draft of the Code of Ethics for Commissioners to adhere to going forward. Feedback was provided.
 - ii. Action: All Commissioners are to review and provide feedback by Tuesday, February 22nd, 2022.

 - i. <u>Discussion: Keshana presented a draft of talking points to create consistency in</u> <u>our upcoming conversations engaging community-based organizations and</u> <u>community members into public hearings, etc.</u>

 - d. Open Meeting Law (Larry)

 - iv. Under the Freedom of Information Act they are able to obtain this information and we can't deny them.
 - v. Larry will continue to look into the law

 - viii. Executive meetings- not for public review, and not entitled to or make public decisions.
 - ix. Action Item: Create a checklist to follow for each meeting.

- III. New Business
 - a. Discussion: Meeting w/ Albany County Judge (Marie)
 - i. Larry attended a meeting with Joan Ramsey, Merton Simpson (Legislator) and an Albany County Judge regarding Redistricting. Merton is concerned that the county has not done a good job on either of the Commissions in giving us any direction or guidance. His concern is, without the direction and guidance we may make some mistakes that open us up to a legal lawsuit again.
 - ii. Thomas Marcille- was one of the lawyers that won the case for the commission.He felt that we needed to hear the pitfalls that allowed them to win the case.Some of the things the county did not do.
 - iii. Districts have to be equal in population. One district can't have 7,000 people and another has 2,000 people.
 - iv. Percentages were also discussed. 45% is not enough to declare a district as MMD. Should be at least 51%.
 - v. He also discussed the intent of the law and why it was drafted. The intent was that the MMD would be driving Redistricting. We would start with our districts, and then the other districts. Merton was concerned that we are being treated as a subcommittee and not the lead committee. That was never the intent. MMD was intended to be the Lead Committee. Our maps should be drawn first. He offered to meet with the subcommittee.
 - vi. Action: We need to define minority only AA, or minorities AA, Hispanic, etc.
