WHEREAS, The Commissioner of the Department of Public Works has requested authorization to enter into an agreement with the New York State Department of Transportation (NYSDOT) in order to accept the conveyance of a right-of-way to Albany County which was previously acquired by New York State in connection with a federal-aid project located in the Town of Colonie that is now complete, and

WHEREAS, The Commissioner indicated that the NYSDOT administered a federal-aid project for Albany County and was responsible for negotiating and closing on all of the right-of-way acquisitions of property regarding the aforementioned project, now, therefore be it

RESOLVED, That the Albany County Legislature authorizes the County Executive to execute all necessary documentation necessary to effectuate the conveyance of said right-of-way, as indicated on the spreadsheets attached hereto, from NYSDOT to Albany County which were previously acquired in connection with a federal-aid project that is now complete in the Town of Colonie, and, be it further

RESOLVED, That the County Attorney is authorized to approve all necessary documents as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials, including seven certified copies to the County Engineer for distribution.
