WHEREAS, Section 205 of the Albany County Charter provides that the vacancy shall be filled by appointment by a majority of the remaining members of the Legislature, now, therefore, be it

RESOLVED, That Richard Touchette, residing at 32 Church Street, Coeymans, NY 12045, is hereby appointed County Legislator from the 37th Legislative District for a term commencing immediately and ending January 1, 2022, and be it further

RESOLVED, That the Clerk of the Legislature is hereby directed to forward certified copies of this resolution to the appropriate County officials.
