AUTHORIZING AN AGREEMENT WITH BETTER HEALTH FOR NORTHEAST NEW YORK, INC. (BHNNY) REGARDING THE CARDIOVASCULAR HEALTH MANAGEMENT PROJECT AND AMENDING THE 2018 DEPARTMENT OF HEALTH BUDGET

By Audit and Finance Committee:

WHEREAS, The Commissioner is seeking authorization to enter into an agreement with Better Health for Northeast New York, Inc. (BHNNY) regarding a coordinated care team approach to address lifestyle change, and increased self-management by Medicaid and uninsured patients with cardiovascular disease, in an amount not to exceed \$142,126, for a term commencing January 1, 2018 and ending March 31, 2019, and

WHEREAS, The Commissioner of the Department of Health has also requested a budget amendment in order to accept said BHNNY funding, now, therefore, be it

RESOLVED, By the Albany County Legislature, that the County Executive is hereby authorized to enter into an agreement with BHNNY regarding a coordinated care team approach to address lifestyle change, and increased self-management by Medicaid and uninsured patients with cardiovascular disease, in an amount not to exceed \$142,126, for a term commencing January 1, 2018 and ending March 31, 2019, and

RESOLVED, That the 2018 Department of Health Budget is hereby amended as follows:

Increase Revenue Account A3492 BHNNY Grant by \$142,126

Increase Appropriations Account A4010.1 by \$61,456 by increasing the following line items:

Increase Appropriation Account A4010.2 by \$4,058 by increasing line item A4010 2 2050 Computer Equipment by \$4,058

Increase Appropriations Account A4010.4 by \$42,410 by increasing the following line items:

Increase line item A4010 4 4020 Office Supplies by \$300

Increase line item A4010 4 4042 Printing and Advertising by \$700

Increase line item A4010 4 4036 Telephone by \$760

Increase line item A4010 4 4038 Travel and Freight by \$160

Increase line item A4010 4 4046 Fees for Services by \$40,490

Increase Appropriation Account A4010.8 by \$34,202 by increasing the following line items:

Increase line item A4010 8 9010 State Retirement by \$11,677

Increase line item A4010 8 9030 Social Security by \$4,702

Increase line item A4010 8 9060 Hospital and Medical by \$17,823

and, be it further

RESOLVED, That the Albany County Attorney is authorized to approve said amendment as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
