**AUTHORIZING THE ACCEPTANCE OF FUNDS FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) AND AMENDING THE 2018 DEPARTMENT OF PUBLIC WORKS BUDGET**

WHEREAS, The Federal Emergency Management Agency (FEMA) has awarded Albany County a total payment of \$196,306 for the Severe Winter Storm Declaration for the March 14-15, 2017 storm, now, therefore be it

RESOLVED, That the Albany County Executive is authorized to enter into an agreement with FEMA for the acceptance of \$196,306 for the Severe Winter Storm of March 14-15, 2017, and be it further

RESOLVED, That the 2018 Department of Public Works Budget be amended as follows:

Increase Revenue Account D4960 Federal Emergency Disaster Assistance by \$89,000

Increase Appropriation Account D5110.1 by \$89,000 by increasing the following Line Items:

D5110 1 9900 Overtime by \$84,000

D5110 1 9952 Compensatory Time by \$5,000

Create and Increase Revenue Account DM4960 Federal Emergency Disaster Assistance by \$107,306

Increase Appropriation Account DM5130.1 by \$5,000 by increasing Line Item DM5130 1 9900 Overtime by \$5,000

Increase Appropriation Account DM5130.4 by \$102,306 by increasing the following Line Items:

DM5130 4 4029 Automobile Parts by \$82,306

DM5130 4 4470 Equipment Repair by \$20,000

and, be it further

RESOLVED, That the Albany County Attorney is authorized to approve said agreement as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
