WHEREAS, The State has agreed to restore an avigation easement over the acquired property as depicted on Map-768-C Parcel 895 to the County of Albany, now, therefore be it

RESOLVED, That the Albany County Executive be, and hereby is, authorized to execute the waive the \$1.00 offer for the easement interests inadvertently acquired as depicted on Map 747, Parcel 873, and be it further

RESOLVED, That the Albany County Executive is authorized to execute the necessary documents to restore an avigation easement as set forth in the attached "Grant of Avigation Easement to the County of Albany", and, be it further

RESOLVED, That the Albany County Attorney be, and hereby is, authorized to approve said documents as to form and content prior to execution thereof, and, be it further

RESOLVED, That the Clerk of the County Legislature be and hereby is directed to forward certified copies of this resolution to the appropriate State, Airport Authority and County Officials.




