## AMENDING THE 2015 ALBANY COUNTY BUDGET: ADMINISTRATIVE ADJUSTMENTS TO VARIOUS POSITIONS

By Audit and Finance Committee:

WHEREAS, The Departments of Management and Budget, Residential Health Care Facility and Sheriff's Office have requested authorization to correct certain salary issues mandated by collective bargaining agreements; changes due to promotions; increased duties and other staffing adjustments in various departments, and

WHEREAS, The Director of Finance requested authorization to create a temporary help line to fund building inspectors on an as needed basis, ensuring that foreclosed properties are inspected on a regular basis, and

WHEREAS, The Albany County Soil and Water Conservation District requested authorization to incorporate funding in the amount of \$385,831 from the NYS Empire State Development Corporation regarding the Flood Mitigation Grant, and

WHEREAS, The District Attorney has been notified by the NYS Division of Criminal Justice Services that an additional \$700 has been allocated to the Motor Vehicle Theft and Insurance Fraud Grant and has requested an amendment to the Department's 2015 Budget, now, therefore be it
