WHEREAS, The County of Albany, pursuant to the Code of Standards and Procedures for the Administration and Operation of Community Colleges under the Program of the State University of New York, may enter into an agreement with the Board of Trustees of a community college to provide post-secondary education services pursuant to the authorization of the governing body of both the qualified local sponsor and the community college, and

WHEREAS, It is in the best interest of the residents of Albany County to expand access to post-secondary educational opportunities and the County seeks to provide its residents with the opportunity to acquire the best post-secondary education, skills and workforce training possible, and

WHEREAS, Schenectady County Community College is authorized to provide the following post-secondary educational opportunities, limited, unless otherwise agreed to in an amended Service Area Agreement, to the locations specified below in addition to educational opportunity being offered by Hudson Valley Community College:

- curriculum leading to certification for Home Health Aide;
- curriculum leading to certification for Home Care Aide;
- curriculum leading to Certified Nurse's Aide certification;
- college readiness courses at locations in Arbor Hill, South Albany and Albany High School for older adult learners;
- Health Information Technology curriculum and Medical Coding and Billing curriculum in Arbor Hill, South Albany and Albany High School:
- Fire Technology Program on behalf of the Town of Colonie and the Colonie Fire Department,

now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with Schenectady County Community College regarding Post-secondary Educational Services in Albany County as listed above in the amount of \$300 per Albany County Student, and, be it further

RESOLVED, That the County Attorney is authorized to approve said agreement as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
