

## RESOLUTION NO. 132

### AUTHORIZING AN AGREEMENT WITH ATLANTIC PAVEMENT MARKING, INC. REGARDING THE STRIPING OF COUNTY HIGHWAYS

By Public Works Committee:

WHEREAS, The Commissioner of the Department of Public Works after an RFP process has requested authorization to enter into an agreement with Atlantic Pavement Markings, Inc. regarding material, labor and equipment necessary for the striping of Albany County roadways commencing May 1, 2011 and ending April 30, 2012 in an amount not to exceed \$145,300 with the option for two one-year renewals, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with Atlantic Pavement Markings, Inc., 15 Industrial Road, Prospect, Connecticut 06712 in an amount not to exceed \$145,300 for the period commencing May 1, 2011 and ending April 30, 2012 with the option for two one-year renewals regarding material, labor and equipment necessary for the striping of Albany County roadways, at the unit costs set forth:
