

RESOLUTION NO. 28

AUTHORIZING THE HIRING OF CERTAIN CRITICAL POSITIONS AND AMENDING THE 2010 ALBANY COUNTY BUDGET AS NECESSARY FOR SAID PURPOSES

WHEREAS, By Resolution No. 441 for 2009, this Honorable Body established a hiring freeze in Albany County, and

WHEREAS, This Honorable Body recognizes the need to hire employees to fill critical and necessary positions, however, before a person is hired, the decision to hire needs to be reviewed and approved by a designated legislative committee, and

WHEREAS, The Personnel and Audit and Finance Committees have reviewed the following positions and have approved said positions as meeting the critical and necessary criteria established in Resolution No. 441, now, therefore be it

RESOLVED, By the Albany County Legislature that the following positions are authorized to be filled and the 2010 Albany County Budget is amended as necessary for said purposes:
