WHEREAS, The program established by Pastor Muller accepts handguns anonymously with no questions asked in exchange for gift certificates to Crossgates Mall or Colonie Center, with the guns turned over to the Albany Police Department for destruction, and

WHEREAS, It is in the interest of Albany County residents to continue support for the ongoing handgun buyback program, now, therefore be it

RESOLVED, That the 2010 Albany County Budget is amended as follows:

Decrease Appropriation Account A1990.4 Contingent Account by \$10,000 by decreasing Line Item A1990 4 4999 000 Misc Contractual Expenses by \$10,000

Increase Appropriation Account A3110.4 by \$10,000 by increasing Line Item A3110 4 4062 000 Gun Buyback Program by \$10,000

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
