AUTHORIZING AN AGREEMENT REGARDING FUNDING FOR THE CHILD ADVOCACY CENTER AND AMENDING THE 2010 CHILDREN YOUTH AND FAMILIES BUDGET

WHEREAS, The Commissioner of the Department for Children, Youth and Families has requested authorization to enter into an agreement with the NYS Office of Children and Family Services regarding funding for the Child Advocacy Center in the amount of \$90,239 commencing February 1, 2010 and ending January 31, 2011, and

WHEREAS, The Child Abuse and Maltreatment Team and Child Advocacy Center grant funding will allow for a coordinated approach for the investigation and prosecution of child abuse cases among the Department for Children, Youth and Families, the Albany County District Attorney's Office, the Crime Victim and Sexual Violence Center, and County law enforcement agencies, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with the NYS Office of Children and Family Services regarding the Child Advocacy Center in an amount not to exceed \$90,239 commencing February 1, 2010 and ending January 31, 2011, and, be it further

RESOLVED, That the 2010 Department for Children, Youth and Families Budget is amended as follows to incorporate said grant funding for 2010:

Increase Revenue Account A3407 Child Advocacy Center by \$26,856

Increase Appropriation Account A6119.2 by \$3,000 by increasing Line Item A6119 2 2001 000 Office Equipment by \$3,000

Increase Appropriation Account A6119.4 by \$23,856 by increasing the following line items:

Increase Line Item A6119 4 4020 000 Office Supplies by \$1,400

Increase Line Item A6119 4 4036 000 Telephone by \$700

Increase Line Item A6119 4 4037 000 Insurance by \$1,200

Increase Line Item A6119 4 4039 000 Conferences, Training, Tuition by \$11,000

Increase Line Item A6119 4 4040 000 Books, Transcripts, Subscript by \$500

Increase Line Item A6119 4 4046 000 Fees for Services by \$600

Increase Line Item A6119 4 4071 000 Property Repair and Rental by \$8,456

and, be it further

RESOLVED, That the County Attorney is authorized to approve said agreement as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
