

## RESOLUTION NO. 51

### AUTHORIZING AN AGREEMENT WITH ATLANTIC PAVEMENT MARKING, INC. REGARDING THE STRIPING OF COUNTY HIGHWAYS

WHEREAS, The Commissioner of the Department of Public Works has requested authorization to enter into the first of two one year renewal agreements with Atlantic Pavement Marking, Inc. regarding material, labor and equipment necessary for the striping of Albany County Highways commencing May 1, 2006 and ending April 30, 2007 in an amount not to exceed \$186,887.08, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with Atlantic Pavement Marking, Inc., 15 Industrial Road, Prospect, Connecticut 06712 in an amount not to exceed \$186,887.08 for the period commencing May 1, 2006 and ending April 30, 2007 regarding material, labor and equipment necessary for the striping of Albany County roadways, at the unit costs set forth:
