

**RESOLUTION NO. 52**

**AUTHORIZING AGREEMENTS REGARDING PERSONAL CARE SERVICES, HOMEMAKER SERVICES AND EXPANDED IN-HOME SERVICES FOR THE ELDERLY PROGRAM (EISEP)**

Introduced: 3/13/06

By Social Services Committee:

WHEREAS, The Albany County Department of Social Services is mandated by NYS law to provide personal care/homemaker services to eligible persons which services are cost-effective as they preclude or delay more costly nursing home care, and

WHEREAS, The Department of Social Services has requested authorization to enter into agreements regarding Personal Care Services, Homemaker Services and Expanded In-Home Services for the Elderly Program for the term April 1, 2006 through March 31, 2007 at NYS Department of Health established rates, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into agreements with the service providers indicated in the attached table regarding Personal Care Services, Homemaker Services and Expanded In-Home Services for the Elderly Program for the term April 1, 2006 through March 31, 2007, and, be it further

RESOLVED, That the rates paid to the service providers shall be subject to negotiation by the Department of Social Services Commissioner or his designee, but in no event shall any rate exceed the NYS Department of Health established rates, and, be it further

RESOLVED, That the County Attorney is authorized to approve said agreements as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.

EISP rates will be held in effect for the entire contract period. In the event that NYS Department of Health increases the maximum allowable rates for Personal Care/Homemaker Services, the rates for the above agencies are proposed to automatically increase as follows: a) Agencies that proposed a rate at or above the current State maximum will be granted an increase to the new State maximum rate. b) Agencies that proposed a rate lower than the current State maximum will be granted a percentage increase, commensurate with the percentage of the current State maximum reflected by their proposed rate.
