I respectfully request the Albany County Legislature's authorization for the \$100,000 appropriation to United Way of the Greater Capital Region to assist with the sale of their former facility's location at 1 United Way, Albany, NY 12205 to Camino Nuevo. This will allow Camino Nuevo to relocate their addiction treatment and recovery facility from their current location at 175 Central Avenue, Albany, NY 12206.

As a non-profit organization in the State of New York, United Way is required to sell their property at full market value, which is reported at \$900,000. With the City of Albany contributing \$100,000 as well, the combined \$200,000 between the City and the County would allow Camino Nuevo to purchase the property and continue their operations and important work on behalf of Albany County residents.
