

**RESOLUTION NO. 82**

**AMENDING RESOLUTION NO. 373 FOR 2016 REGARDING FOSTER CARE FOR CHILDREN IN ALBANY COUNTY**

By Social Services Committee:

WHEREAS, By Resolution No. 373 for 2016, this Honorable Body authorized two-year agreements with fifty-eight foster care providers for children whose care has become the responsibility of Albany County, and

WHEREAS, The Commissioner of the Department for Children, Youth and Families has requested authorization to amend Resolution No. 373 for 2016 to indicate the addition of those local DSS Offices listed below regarding foster care commencing January 1, 2017 and ending December 31, 2018, and

WHEREAS, Consideration for the services rendered by the agencies is in the form of a rate established by the New York State Department of Children and Family Services as a maximum per diem reimbursement per child, now, therefore be it

RESOLVED, By the Albany County Legislature that Resolution No. 373 for 2016 is amended to indicate the addition of two-year agreements with the following agencies at rates determined by New York State with notice to the County for the period commencing January 1, 2017 and ending December 31, 2018:
